2021 Rules and Regulations for Food Vendors

A completed and signed application, which is required to be considered for admittance to the 2021 Sunflower Fair, indicates that the vendor has read and agrees to abide by these Rules & Regulations. Please read this document thoroughly before submitting your 2021 Sunflower Fair Application Form.

Location & Time:	<ul> <li>Saturday, September 18, 2021: 8:00 AM- 4:00 PM</li> <li>Food Vendors will be assigned booth spaces along Michigan Avenue.</li> <li>Vendors are required to be open during these hours.</li> <li>The fair is held <u>rain or shine</u>. Failure to abide by this requirement may result in ineligibility for future fairs.</li> <li>Vehicles must be moved out of fair area by 7:30 AM</li> <li>Early Tear down is NOT Permitted. The fair closes promptly at 4:00 PM.</li> </ul>
Set-Up:	<ul> <li>Set up occurs between 6:00 AND 7:30 AM (CDT) Saturday, September 18th.</li> <li>Finalized booth assignment &amp; set up instructions will be e-mailed September 3, 2021. Vendor vehicles may be parked on any legal street out of the fair area or in the parking lots of Lincoln Elementary School at Harrison &amp; Clay Streets. Handicap Parking is NOT Guaranteed.</li> </ul>
Rules & Regulations:	<ul> <li>Electrical Power is available for food vendors but you are required to bring your own 12 gauge extension cord (100 feet or more.)</li> <li>There is no guarantee of exclusivity of your product line.</li> <li>You are expected to be present and provide your product the entire time of the fair.</li> <li>Dumpsters will be available. Vendors are responsible for the cleanup of assigned booth area and disposal of your own trash. Failure to do so will result in a ban for the following years.</li> <li>All exhibitors are responsible for collection of their own sales tax.</li> <li>Exhibitors are responsible for their own booth set up including tables, chairs and display items. All Items must fit entirely inside the designated 10' × 10' space.</li> <li>All vendors selling food must submit a Certificate of Insurance of one million dollars (\$1,000,000) with their application and vendor fee.</li> <li>The Certificate of Insurance needs to list the La Porte Economic Advancement Partnership, 809 Washington Street La Porte, IN 46350 as Additional Insured for protection against damages in the event of an injury occurring at the fair or an injury caused by the products the vendor sells at the fair.</li> <li>Failure to provide a Certificate of Insurance, as outlined above, will prohibit vendors from participation in the Sunflower Fair.</li> </ul>
